Re: Extension of State of Emergency

Thank you for writing to me and expressing your opposition to Daniel Andrews' proposal to extend the State of Emergency for a further twelve month period.

I concur with your concerns about this plan to redraft legislation and provide the Victorian Government with unprecedented wide-ranging powers. I have had more than 700 emails on this matter in the past 24 hours, and so can state with certainty that our outrage is widely shared. I have tried to address most aspects of your email here, but given the volume of correspondence I have received, and the need to update you quickly, I hope you appreciate that I have had to summarise my position.

The Opposition vigorously opposes the radical proposal and I, alongside my colleagues will vote against **any** Bills that seek to implement it in the Parliament.

The Labor Government's insistence on expanding its powers should be of deep concern to anybody who cares about democracy and the rights of individuals.

Both the State of Emergency and State of Disaster have led to significant destruction of businesses, forced an estimated 250,000 to 400,000 Victorians to become unemployed and has led to draconian lockdown measures to which we have all now reluctantly become accustomed.

The current restrictions constitute a serious erosion of individual rights and are destroying lives and hundreds of thousands of livelihoods.

In Parliament, I have asked the Premier to clarify the specific objective of the lockdowns with respect to case numbers and the rationale behind it, including supporting data around the cost to the state and lives lost to suicide.

I'll continue to oppose expansions of Government powers and restrictions on public or parliamentary scrutiny. I have attached a Letter to the Editor I issued yesterday, detailing my criticism of over-mighty state Premiers who are using local politics to trample individuals' rights, damaging our country's unity as well as its economic and social fabric.


