Dear Bob.

Thank you for writing to me with your concerns about the State of Emergency,

I understand how difficult this time is for everyone. The return to Stage 3 lockdowns for regional Victoria and the shut down of the NSW border have disrupted many people's lives in our community.

Since this pandemic began, I have always deferred to the advice of the medical experts. As a former nurse and rural health researcher, I take that advice very seriously. The evidence we have seen overseas in countries where the COVID-19 pandemic has not been contained, show us the profound dangers of losing control of this virus.

It is also clear that we will not be able to begin our economic recovery until we take control of the virus. In this case, I believe that the best thing we can do for the economy is to get on top of the virus. Loosening restrictions whilst the virus is spreading through the community at high levels would neither be a good economic nor a good health outcome.

However I share your concerns at the Victorian Premier's decision to extend the State of Emergency for another 12 months.

It is important to note a few things.

The State of Emergency is not the lockdown. The decision to extend the State of Emergency does not mean that our current lockdowns will be extended for 12 months. These are different things.

The State of Emergency declaration is a legal instrument that is necessary to enable the Victorian Chief Health Officer to impose rules for human biosecurity. For example, without the State of Emergency, the Victorian Government would not be able to compel people to undergo mandatory hotel quarantine when they arrive in Australia. We would all agree that we should maintain the hotel quarantine rules for some time to come.

The Victorian Public Health and Wellbeing Act only allows for a state of emergency to run for a maximum of six months. The current State of Emergency was declared on March 16, and after several four-week extensions, is due to expire under the act on September 13. This means that without extending it, we would not be able to impose many of the rules which are keeping us safe.

However I believe that a 12 month extension is beyond what is appropriate right now. I think a shorter extension would be appropriate and we can reassess the situation as it unfolds.

This is a matter for the Victorian Government and I encourage you to contact your local State MP to express your concerns, who will be able to communicate them to the Victorian Parliament.
